DeDe Reynolds - Chairman, called the meeting to order at 8:31 a.m. and a quorum was established.

ITEM I: First on the agenda was review of the previous meeting minutes.

Lawrence Walker, Commissioner, moved to approve the minutes as written for the Civil Service Commission meeting held on July 23, 2014. David Hurt, Vice-Chairman, seconded the motion. The minutes were approved as presented.

ITEM II: The lists of new employees, step increases, transfers, promotions, demotions, bypasses, temporary assignments and disciplinary actions were reviewed.

ITEM III: Chairman Reynolds opened the floor for comments regarding the appeal filed by Lt. Jimmy Johnson regarding questions 57, 61, 91 and 95 of the Police Captain's test given on 7/30/14.

At 9:08 a.m., DeDe Reynolds, Chairman recessed the meeting to allow time for Viola Frausto, Recruitment Coordinator, to rebuild the register.

The meeting was called back to order at 9:16 a.m. by DeDe Reynolds, Chairman.

Lawrence Walker, Commissioner, moved to accept the revised eligibility register for Captain. David Hurt, Vice-Chairman, seconded. Motion carried.
