

RESOLUTION NO. 07-08-25-3

A RESOLUTION AFFIRMING AND FURTHER CLARIFYING RESOLUTION NO. 06-16-25-1 TO INCLUDE AND ATTACH ALL PUBLISHED VOTING TABULATIONS AND CERTIFICATE OF ELECTION RELATED TO CANVASSING THE RETURNS HELD IN THE CITY OF AMARILLO ON THE 7TH DAY OF JUNE, 2025, FOR CERTAIN CITY OFFICES.

WHEREAS, on this the 16th day of June 2025, came to be considered by the Amarillo City Council the canvass of the returns of the City Officers Runoff Election held in the City of Amarillo on the 7th day of June, 2025, for the purpose of electing a Councilmember, Place No. 3; and

WHEREAS, the election returns duly canvassed by Resolution 06-16-25-1 included and are a product of all voting tabulations showing the total votes by precinct, the early tabulations of votes reported by precinct, and all other voting information duly certified and published as required by law the same of which is attached hereto and incorporated herein for all purposes; and

WHEREAS, the Certificate of Election for the newly elected candidate as Councilmember, Place No. 3, is also attached hereto and incorporated herein for all purposes; and

WHEREAS, this Resolution merely for the purpose of clarification and for further publication of voting tabulations that were not attached to Resolution No. 06-16-25-1 nor was the Certificate of Election presented, and Resolution No. 06-16-25-1, Canvassing of Returns, approved on June 7, 2025, is hereby affirmed and remains in full force; and

WHEREAS, the City Council has canvassed the returns of said election and it appears from said returns, duly and legally made, that there were 9,281 valid and legal ballots cast in said election; and that each of the candidates in said election received the following votes:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AMARILLO, TEXAS:

SECTION 1. That all aforementioned findings hereby fully affirmed and that said election was duly called; that notice of said election was given and held in accordance with law; and that said election and the returns thereof have been duly canvassed by the City Council and approved on June 7, 2025 per Resolution No. 06-16-25-1.

SECTION 2. That at said election:

A. David Prescott received a majority of the votes cast for and was duly elected as Councilmember, Place No. 3.

SECTION 3. That this Resolution is for the sole purpose of clarification and further publication of the attached voting tabulations submitted by both Randall County and Potter

County the same of which was canvassed by Resolution No. 06-16-25-1, and the attached Certificate of Election for the newly elected candidate as Councilmember, Place No. 3.


