THRESHOLD CRITERIA

Required but not scored. If “no” for any threshold criteria, the project is ineligible.

Federal Threshold Criteria: In addition to the criteria listed below, agencies must provide proof of the following: Active SAMS registration; Valid UEI Number; Nonprofit documentation; Not disbarred and otherwise federally qualified; Financial capacity and sufficient financial management system; and Code of Conduct on file with HUD.

CoC Threshold Criteria: Include participation in the Homeless Management Information System (HMIS); use of qualified housing types; implementation of a housing with supportive services; documentation of the required minimum match; and policies that ensure non-discriminatory access to services for all participants.

	<p>Agency can demonstrate that the proposed project will require program participants to take part in services and will offer connections to treatment facilities, employment, and childcare facilities to facilitate employment.</p> <p>For TH Projects to earn these points:</p> <ul style="list-style-type: none"> Agency can demonstrate that project will provide a mixture of up to 40 hours per week of customized services and/or help clientele achieve 40 hours of employment, excluding participants over the age of 62 who have a physical disability/impairment or a developmental disability; and Agency has a plan to ensure at least 50% of participants exit with employment income. <p>For DV Bonus Projects to earn these points: Program incorporates best practices to serve survivors of domestic violence, dating violence, sexual assault, and/or stalking. Program demonstrates staff expertise on VAWA regulations, safety planning, and survivor-specific networks and services.</p>	10	
	The plan details services to be provided in-house, versus those provided via referral to partners with consideration for transportation logistics. Substance use treatment services to be provided on-site when possible.	10	
	The program description should include whether the project will be leveraging health care resources (proven by attaching written commitment from a health care organization who will provide substance use treatment or recovery services to all interested program participants who qualify OR provide services equal in value to at least 25% of funds being requested).	5

	Project budget balances robust, yet cost-effective expenses to support the proposal. No line items appear unnecessary, nor unjustified by the proposal. Staffing is sufficient to the scope of the program, with consideration for the clientele's unique needs.	4	
	Organization has experience with federal funds and demonstrates financial capacity to manage a federal grant.	3	
	Organization has no unresolved findings and clean monitoring reports.	3	
	<p>PSH Projects: The project is designed to serve elderly individuals and/or individuals with a physical disability/impairment or a developmental disability, not including substance use disorder. Applicant has prior experience with this population. Applicant will prioritize these populations.</p> <p>RRH Projects: Applicant has prior experience providing tenant-based rental assistance to the target population and successfully helps households achieve self-sufficiency within 3-24 months.</p> <p>TH Projects: Applicant has prior experience operating transitional housing or other projects that have successfully helped homeless individuals exit homelessness within 24 months.</p>	3	

	Employment Income: Agency can demonstrate experience serving the target population and has a plan to ensure permanent housing retention/exits, and connections to increasing employment income.	5
